- A, 3/15, A-20. Quarterback A12 is back to pass. Eligible receiver A87 is blocked by B43 and forced out of bounds at the A-33. A87 returns inbounds at his first opportunity at the A-36. A12 then throws a legal forward pass, which A87 catches at the A40 and advances to the A-45, where he is downed. (7-5-6a; 7-5-6d; 7-5-9; 7-5-13)
 - a. No foul
 - b. Illegal block by B43
 - c. DPI by B43
 - d. Illegal participation by A87
- 2. A, 4/3, A-26. Team A is in a scrimmage kick formation with four linemen numbered 50-79. A-90 is on the line inside flanker A-83, who is on the end of the right side of the line. The ball is snapped to the "punter," who throws a legal forward pass to A-90 at the A-35, where he is downed. (7-2-5b, Exc 2; 7-5-1; 7-5-6a; 7-5-12; 7-5-13)
 - a. Legal play as A-90 was legally in the game as the SKF exception to the rule
 - b. A, 4/8, A-21
 - c. B, 1/10, A-21
 - d. B, 1/10, A-30
- K, 4/11, R-30. K's field goal attempt is short and rolling on the ground when a K player muffs it at the R-10. The ball continues to roll and comes to rest at the R-1, where it is touched but not controlled by another K player. After a second, an R player picks up the ball and runs 99 yards for a touchdown. (5-1-3e; 4-2-2f; 6-2-7)
 - a. R touchdown
 - b. R, 1/10, R-1
 - c. R, 1/10, R10
- 4. K's attempted onside kick from the K-40 travels to the K-48, where it is caught by K43. (6-1-7; 6-5-6)
 - a. K, 1/10, K-48
 - b. K43's catch is a foul only if a team R player was in position to catch the kick
 - c. Foul by K43 for KCI
 - d. No first touching infraction

- 5. A, 3/10, B-20. At the snap, A89 is lined up at the right end of the formation, facing B's goal with neither his head nor foot breaking an imaginary plane parallel to the LOS through the waist of the snapper; but A89's head does break the plane of an imaginary line parallel to the LOS through the waist of his nearest teammate, lineman A75. Quarterback A12 drops back to the B-25 and throws a forward pass to A89, who muffs it at the B-10. (2-32-3; 2-32-9; 7-2-3; 7-2-5a; 7-5-1, 7-5-2, 7-5-6; 7-5-10; 7-5-12; 7-5-13)
 - a. Legal play
 - b. Illegal touching. A, 4/15, B-25
 - c. Illegal forward pass. A, 4/20, B-30
 - d. OPI. A, 4/25, B-35
- 6. Which of the following is an option for team R when a free kick goes out of bounds untouched by any team R player? (6-1-9)
 - a. Accept a 5-yard penalty from the previous spot and have K re-kick
 - b. Accept a 5-yard penalty from the succeeding spot
 - c. Put the ball in play at the inbounds spot 25 yards beyond the previous spot

- 7. A, 1/10, B-30. Quarterback A7 drops back to the B-40 and attempts a screen pass. Intended receiver A45 muffs the pass at the B32, and the ball continues downfield, where it is caught by A53, who had been blocking a team B player at the B-35. (7-5-6; 7-5-7; 7-5-13; 7-5-12; 7.5.10E,)
 - a. No foul by A53. Because the pass was touched behind the neutral zone, it is considered to be a pass that did not cross the neutral zone.
 - b. Ineligible player downfield
 - c. Illegal touching

- 8. A, 1/10, B-35. Quarterback A6, back to pass, is flushed from the pocket and scrambles toward the sideline. As several team B players move in, A6 turns, and with an underhanded motion, throws the ball backwards and out of bounds at the B-45. (7-4-1)

 - b. Legal play only because A6 threw the ball underhanded rather than overhanded

- 22. A, 4/16, A-35. Team A trails by 2 points with 55 seconds remaining in the fourth quarter. Quarterback A12 throws a legal forward pass toward A81. During the pass, B43 arm-bars A81 at the A-45, and the pass is incomplete. After the pass is incomplete, A81 curses B43. (5-1-3b; 5.1.2E)

- 23. A, 3/3, A-25. Following the ready for play, snapper A78 places one or both hands on the ball. As A78 begins the snap, B67 reaches in and contacts the ball. A78 continues the snap and is able to snap the ball to quarterback A9. (2-40-2; 2-40-3; 7-1-2; 7-1-3; 7-1-6b)

- 24. Team A is lined up and set for one second with the interior lineman in a two-point stance. On the quarterback's signal, the interior linemen drop to a three-point stance, and flanker A22, who was on the line of scrimmage, goes in motion parallel to the LOS and at the snap continues running 4 yards behind the line. (7-2-6; 7-2-7)
